# 2 PROJECT DESCRIPTION

NEX-LABS aims to support the implementation of clean technologies for sustainable and resilient increase of agri-food sector production based on a more efficient use of energy (renewable/solar solutions) and water (wastewater treatment, water harvesting or reuse solutions) in MPC region thanks to the contributions of ICT such as blockchain technology, Internet of the Things (IoT), Artificial Intelligence (AI), Machine Learning and Big Data.

NEX-LABS will contribute to the creation of a sustainable and resilient agro food sector based on NEXUS driven Open Living Labs (NDOLL) approach, thus strengthening technology transfer, cooperation industry-academia, increasing commercialisation opportunities and innovation-driven growth.

# 3 PURPOSE OF THE CONTRACT

Implementation of Incubation Vouchers activity within the activities of NEX-LABS Project. The objective of the service provider is to:

- Provide 4 selected WEF-NEXUS beneficiaries (startups or entrepreneurs) with incubation space (co-working space, offices) and other related added-value activities associated with incubation (mentorship, networking, legal support, training), thus improving their growth prospects while reinforcing and nurturing NEXUS open innovation ideas.
- Conduct Needs assessment of technological and industrial viability, technological developments of processes, products and services. Recruit technical experts based on the assessment to provide advisory services and co-working space providers.









- As a proof of service completion, the service provider should develop with the beneficiary a narrative report including summary of testing activities conducted, beneficiary's interpretation of results, the anticipated impact both qualitatively and quantitatively and an activity assessment, including how was the visibility of NEX-LABS contribution ensured.

# **4 SCOPE OF ACTIVITY AND REQUIRMENTS**

- The service provider selected will be responsible for assisting 4 WEF-NEXUS startups/entrepreneurs selected by RSS based on defined selection criteria.
- The service provider should be willing to interact with the project partnership and to participate in teleconference meetings if required for the development of the proposed services.
- The service provider can recruit trainers/experts with specific expertise to assist the beneficiaries based on the needs assessment.

# 5 TARGET BENEFICIARIES

The targeted number of beneficiaries is 4 from eligible territories in Jordan, composed mainly of Entrepreneurs/Startups providing products/services in water, energy, and food sectors seeking to be incubated in order to improve their success and growth potential.

## 6 ACTIVITY OUTCOMES

NEX-LABS Testing Vouchers aim at empowering and providing 4 entrepreneur or start-ups who are working on NEXUS-related technologies with access to offices, co-working space, advisory services, and trainings. The prospective beneficiaries will benefit from a needs assessment followed by incubation services worth 20,000 euros. This voucher is an instrument to provide working and community space as well as capacity building services for new promising businesses addressing NEXUS challenges in the region which will enable them to validate their model and upscale their businesses.

The service provider will work closely for 6 months with the beneficiaries to match them with the right consultants, rent a convenient space, and offer them the right trainings and tools.

The outcome of the beneficiary/service provider collaboration can be:

- Avoid early pitfalls
- Rapid business model validation
- Improved survival and growth prospects
- New products/services launched
- Developed marketing strategy

The service provider will be selected based on:

#### Personal DATA

- 1.
