-BACKGROUND INFORMATION

- **Project Description:** The Technology Transfer and Capitalization of Water Energy Food NEXUS (WEF-CAP) project aims to support commercialising and deploying innovations in water, energy and food (WEF-NEXUS) which would allow improving resilience and efficiency in the use of these critical resources. Considering joint challenges at regional and cross-border levels and the fragmented business ecosystem lacking a cross-Mediterranean coherent framework, WEF-CAP will combine the capitalisation and expansion of tools and methodologies used for innovation commercialisation with the capitalization of WEF innovations in efficient practices for replication across the Mediterranean area. This will be done through the support of sustainable and resilient agri-food sector production, thus improving energy and water efficiency: renewables, wastewater treatment, water harvesting and reuse, etc. WEF CAP will apply past and ongoing WEF efficient practices and policies for replication under the framework of a meta cluster, reinforcing networks while mainstreaming gathered territorial evidence for effective capitalisation. A successful implementation will enhance the regional SMEs' competitiveness and job creation, generating spillover effects in knowledge, resource efficiency, and quality of life.
- Project Objective: To consolidate a water, energy, and food regional meta cluster that fosters cooperation and tech transfer while mainstreaming policy impact for innovation-driven growth.

-Purpose of the contract:

Organisation of Multistakeholder WEF NEXUS Capitalization Conference, including side events such as Networking café, Clustering TEDx, Multistakeholder accelerator workshop and capitalization nights events.









Activities under this ToR Events' organization

1.1 Multistakeholder Capitalization conference

1.1.1 Description of Conference

This conference is a dynamic three-day event designed to bring together a diverse group of stakeholders, partners, experts, and researchers in the fields of water, energy, and food (WEF). The conference aims to foster collaboration, promote knowledge sharing, and highlight the outcomes and achievements of the WEF-CAP project, while also addressing the challenges faced throughout its implementation.

The conference will feature "specific events" alongside its technical and side sessions which are Networking café, Clustering TEDx, and capitalization nights events (see below description of these specific events). *Optionally* capitalization nights specific event can be organized as a guided tour for interested participants to a facility related to WEF serving as good practice in the region. The culmination of this conference will result in a comprehensive set of policy recommendations, collaboratively developed by participants from diverse communities. These recommendations will draw upon the insights and expertise of the multidisciplinary team assembled throughout the various project phases, incorporating the contributions of technical experts, researchers, public consultation, and policymakers. The conference is tentatively scheduled to take place between 24th-26th of September, 2023, fostering an environment of collaboration and knowledge-sharing among all attendees.

The objectives of the activity are:

- 1. Develop policy recommendations: Foster a consensus among partners and stakeholders on key policy recommendations that can drive positive change in the focus areas of the conference.
- 2. Promote WEF-CAP project outcomes: Showcase the achievements, outcomes, and lessons learned from the WEF-CAP project, emphasizing its value and impact on the targeted areas.
- 3. Highlight project achievements and challenges: Provide a platform for participants to discuss the successes and obstacles encountered throughout the course of the project, facilitating knowledge sharing and learning.
- 4. Facilitate networking and capitalization: Encourage networking and collaboration among WEF experts, researchers, entrepreneurs, and stakeholders, fostering the exchange of ideas and promoting the capitalization of WEF nexus activities.









1.1.2 Mode of Implementation

- 1. The first day of the conference will cater to a wide range of stakeholders, featuring technical sessions such as Clustering TEDx like-style sessions to inspire and engage attendees, complemented by a networking cafe to facilitate connections and conversations among participants. Towards the end of the day, a capitalization night will be held, where WEF experts, researchers, and entrepreneurs will showcase their activities, highlighting the progress and achievements within the WEF nexus.
- 2. The second day of the conference will focus on capitalization aspects and will be dedicated to diving deeper into the outcomes and lessons learned from various WEF nexus initiatives. Participants will engage in policy dialogue activities to discuss practical applications and implications of the project results, fostering collaboration and innovation among stakeholders.
- 3. Policy recommendations development: Throughout the conference, participants will be encouraged to actively engage in discussions and debates, with the goal of reaching a consensus on policy recommendations. This process will be guided by input from the multidisciplinary team, including technical experts, researchers, public consultation, and policymakers.

By incorporating these elements, the conference aims to create an interactive and enriching platform for participants to share their experiences, knowledge, and ideas, ultimately contributing to the development of effective policy recommendations and promoting the outcomes of the WEF-CAP project.

1.1.3 Main foreseen activities of service provider

Overall organisation of the conference and specific events including:

- 1. Pre-conference planning: A dedicated WEF-CAP team will work with service provider in preconference planning and partnership formation with various actors to maximise the impact of the conference and the specific events.
- 2. Coordinating logistics: The service provider team will be responsible for organising the conference, including selecting the venue, coordinating with speakers and attendees, transportation, accommodation, catering, and AV equipment. This team will also be tasked with promoting the event to ensure maximum stakeholder participation.
- 3. Developing and managing the budget for the event, including negotiating contracts with vendors, tracking expenses, and preparing financial reports.









- 4. Specific Events organisation: The conference will also feature various activities alongside its technical and side sessions, such as the Networking Café (around 50 participants), and capitalization night events (around 50 participants), and Clustering TEDx (around 100 attendees) to encourage interaction and exchange of ideas among attendees. These activities will be designed to facilitate collaboration and discussion on WEF-CAP project outcomes and challenges, as well as promote networking and capitalisation of WEF nexus activities.
- 5. Prepare testimony, documentary video and press release of the event.
- 6. Printing of relevant materials and working closely with the project manager to ensure meeting visibility guidelines and overall organisation.
- 7. Post-conference follow-up: After the conference, the organizing team will compile the agreed-upon policy recommendations and, with the support of the service provider distribute them to all relevant stakeholders, ensuring the outcomes of the WEF-CAP project are effectively communicated and utilized.

1.2 Specific events

1.2.1 Clustering TEDx

The "TEDx-like Talks" event is designed as a local gathering where the triple helix community – encompassing academia, industry, and government – can come together to focus on the WEF nexus through a bottom -up approach. Covering a diverse array of topics, these engaging talks aim to promote learning, inspiration, and thought-provoking conversations on critical issues related to the WEF nexus. The event will also involve volunteers, fostering meaningful connections and community engagement while raising awareness of the WEF nexus.

This unique event offers numerous benefits to its participants, including researchers, entrepreneurs, students, and government representatives from universities, government bodies, and industry sectors. By providing a platform for those who have worked on impactful projects, implemented innovative solutions, or developed cutting-edge technologies, the event will enable them to share their expertise and success stories, as well as the challenges encountered throughout their journeys. Moreover, the TEDx-like Talks will address the needs and opportunities in the WEF nexus sector, promoting collaboration and knowledge-sharing among all stakeholders.

The objectives of the TEDx-like talks activity are as follows:

- Share expertise, inspirational success stories, and lessons learned from participants and stakeholders, encapsulating their experiences and achievements.
- Expand participants' perspectives on the unique challenges they may face while establishing businesses, fostering divergent thinking and problem-solving.
- Enhance attendees' understanding of and engagement with WEF-related issues.









Activity Format

The event will be held in a physical format, featuring guest speakers who will address the following topics:

- Challenges encountered during the project implementation.
- Lessons learned throughout the project journey.
- Best practices in the WEF nexus sector.
- Recommendations for overcoming obstacles and addressing challenges.
- Strategies for identifying and capitalizing on opportunities.
- Utilizing skills and talents to drive success in the WEF nexus field.

1.2.2 Networking Café

The Networking Café is an interactive and engaging event designed to facilitate discussions and knowledge-sharing among society members, ecosystem representatives, policymakers, and government bodies.

Objectives of the activity are as the following:

- 1. Encouraging participants to share thoughts, ideas, and challenges they face in their respective fields.
- 2. Highlighting opportunities and addressing challenges among society members
- 3. Providing a platform for participants to interact, discuss opportunities they can benefit from, and strategize on how to overcome potential challenges while sharing expertise.

Activity Format:

Each Networking Café will be held physically and last for 2 hours. Speakers will deliver proactive talks, and then engage with attendees in the café setting to further discuss the topics presented in the sessions.

- Participants can register for their chosen café and book appointments with peers in advance, ensuring meaningful and targeted connections.
- Post-event evaluation surveys will be distributed to gather feedback and inform the preparation of an output report, helping to refine the Networking Café experience for future events.

1.2.3 Capitalization Night

Capitalization Night event is an interactive event designed to foster engagement and collaboration among researchers, entrepreneurs, and the audience in a casual setting. This event will feature various interactive activities, including one or more of the following: hands-on experiments, science shows, debates, researchers' dating (meet researchers/ask questions), competitions, and guided visits related to the WEF NEXUS.









The objectives of the activity:

- 1. Encourage efforts to address WEF-NEXUS-related issues.
- 2. Emphasize the importance of capitalizing on collective efforts to achieve impact.
- 3. Promote high-quality projects across Mediterranean partner countries and beyond.
- 4. Demonstrate the impact of WEF research on improving people's quality of life.
- 5. Stimulate interest in WEF science and technology aspects among the wide range of stakeholders and young professionals in particular.

1.2.4 Multistakeholders Accelerator Workshops

The accelerator workshops will help us get an initial reaction and feedback from national political makers. The workshops will be animated by a professional that will engage policy makers (each WS will be attended by 10-15 policy makers), in addition to members from media to ensure wider visibility. A final consultation document will be developed with recommendations.

Objectives of the activity:

- 1. Build the capacity of involved stakeholders and share thoughts and different perspectives.
- 2. Promote discussions among stakeholders and policy makers.
- 3. Support the output represented in the consultation document.
- Subcontracting

- Personal DATA
- 1.
