INVESTMED **ABOUT**

MSMEs in the Mediterranean region face important challenges in terms of sustainability, capacity to innovate, competitiveness and internationalisation. These challenges call for new solutions in order for MSMEs to maintain their existence and to enhance growth. Making the economy greener, developing natural assets and enhancing innovation and creativity can provide economic, knowledge-based and environmental benefits to the Mediterranean region.

INVESTMED addresses economic and environmental challenges, supporting sustainable, creative and innovative business opportunities for young people and women in Egypt, Lebanon and Tunisia. INVESTMED is set to benefit MSMEs via training, coaching and sub-granting. It will also provide support for public authorities by enhancing their capacities to encourage and to facilitate MSME access to Intellectual Property Rights (IPR).

INVESTMED has a duration of 30 months, with a total budget of €3.8 Million, of which €3.4 Million (90%) is funded by ENI CBC MED

Project Kick-off Meeting and Press Conference

INVESTMED was officially presented on 24 November 2020 through a virtual conference.



First Session: Official Start meeting, hosted by BUSINESSMED.

The meeting began with a welcome and opening remarks by the President of BUSINESSMED Barbara Beltrame. The keynote speaker of the sessions was Mohammed Elrazzaz, Economic Development and Employment Division, Ufm.

Representing the ENI CBC Med Programme, Vincent Ernoux, Branch Office Coordinator for the Western Mediterranean ENI CBC Med Programme, and Samira Rafrafi, Manager of cross-border cooperation, ENI CBC Med Programme focal point for Tunisia, who offered insights for the successful completion of the project.

The first session was moderated by Jihen Boutiba, General Secretary BUSINESSMED.



Second Session: Public Press Conference, hosted by the Euro-Mediterranean Economists Association - EMEA

The session started with the welcome and introductory remarks by the Fabrizio Paloni, Managing Authority Coordinator of the JTS, ENI CBC MED Programme 2014-2020. This address was followed by Sihem Larif, Advisor to the Minister of Higher Education and Scientific Research- Tunisia, who spoke about the importance of engaging young entrepreneurs.

INVESTMED's structure, focus and aims were presented by the President of EMEA, Prof. Rym Ayadi, who highlighted that "The INVESTMED project aims to support the development of new, sustainable entrepreneurship and business initiatives in the green, blue and creative economic sectors, in order to create new sustainable economic opportunities and decent jobs for young people and women in Egypt, Lebanon and Tunisia."



Following the official presentation, the partners of INVESTMED discussed with journalists, entrepreneurs and other stakeholders the objectives and opportunities of the project. The session was moderated by Cristina Giner, EURONEWS correspondent, and it was broadcast live on Facebook, achieving over 10,000 views.



PROGRESS AT A GLANCE

Launch of workgroup for the mapping of Mediterranean entrepreneurship ecosystems in the green, blue and creative economic sectors, and for the design of the training modules

On February 2021, the Technical Sub-group's expert partners on mapping and training of INVESTMED, launched the mapping of the entrepreneurship ecosystems of the green, blue and creative economic sectors of Egypt, Lebanon and Tunisia.

The mapping of the entrepreneurship ecosystem and outreach activities aims to identify and engage with the INVESTMED target groups, such as recently established enterprises, entrepreneurs, university students interested in initiating their own business, investors, Business Support Organisations, business incubators, etc. The mapping process is led by EMEA in collaboration with the partners of INVESTMED.

Furthermore, the Technical Sub-group initiated the design and methodology of the training modules for the sustainable business management training programme. INVESTMED aims to organise 21 sustainable business management training events, targeting mainly young people and women entrepreneurs. The training is led by LUMSA, in collaboration with the partners of INVESTMED.
