KEY POLICY POINTERS

Raising awareness and generating interest and engagement while fostering the quality and the values of projects' outcomes, are core to the Med strategy to upgrade innovation systems and Non-Conventional Water (NCW) practices in line with the Union for Mediterranean (UfM) Water Agenda.

The Mediterranean Alliance intends to ensure the sustainable capitalisation of best practices (BPs) and their replicability. It is a collective learning vehicle that should allow for more effective policies in line with investment channels and thus more relevant innovation processes.

"Structuring the way to implement a sustainable capitalisation strategy that overarches BPs and Enabling Environment"

According to this encompasses challenge, partners and relevant stakeholders engaged in the Innovation Camps debated, interacted and identified the main challenges on the pathway to fostering change in the Mediterranean.

An open and dynamic platform (<https://bpinventory.com/>) with data management and analysis functions and the possibility to connect to other platforms. It allows to systematise, cluster, extract and share know-how, highlighting contexts, impacts and sustainability routes to make BPs transferable and reusable.

14 published, 5 under assessment
