

INFORMATION NOTE ON PERSONAL DATA PROCESSING

Regulation (EU) 2016/679 (GDPR - General Data Protection Regulation)

This information is given in accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (GDPR - General Data Protection Regulation) for personal data processed by the Sardinian Regional Government as Managing Authority of the ENI CBC Programme (hereinafter referred as the "Programme"), with manual and/or computerised methods.

4. PURPOSES OF THE DATA PROCESSING

Pursuant to art. 13 of the Regulation, the processing of personal data, concerning the Legal Representative and other natural persons of the Applicant/Lead Beneficiary and partners, conferred as part of the procedure of selection and grant award of the Programme, or otherwise collected by the Managing Authority for this purpose, is necessary for the selection of the proposals and execution of the contracts (Article 6) and is aimed solely at the selection and implementation of the projects and the related activities.

In relation to the aforementioned purposes, the processing of personal data takes place using manual, informatic and telematic tools, with logic strictly related to the aforementioned purposes and, in any case, in order to guarantee the security and confidentiality of the data. The data may also be processed on the basis of qualitative, quantitative and temporal criteria identified from time to time.

The operators of the Administration identified as persons in charge of the processing may become aware of the aforementioned personal data.

The storage duration of personal data is at least 5 years after the payment of the final balance by the EC to the ENI CBC Med Program, as established by Art. 70 of the "Commission Implementing Regulation (EU) No 897/2014".

5. RIGHTS OF THE DATA OWNER

The interested party, by email to the holder's delegate, at any time, has the right:

- to have access to their data (article 15 of the Regulation (EU) 2016/679). The appropriate request shall be made to the Data Protection Officer – Processor of personal data at the Sardinia Region (see details at previous par. 3);
- to obtain the correction of incorrect personal data (Article 16), the total cancellation (Art.17) and the limitation of processing (Article 18);
- to oppose the treatment (Article 21);
- to lodge a complaint with the “Garante per la protezione dei dati” which headquarters is in Piazza di Monte Citorio n. 121, 00186 – ROME (<http://www.garanteprivacy.it/>), pursuant to article 77 of Regulation 2016/679 / EU, or shall have the right to an effective judicial remedy to be brought before the appropriate courts (Art. 79).
