## WHEREAS

CROSSDEV is a four-year project started in September 2019, co-funded by the European Union through the ENI CBC MED Programme 2014-2020, implemented by a consortium of entities composed of: Comitato Internazionale per lo Sviluppo dei Popoli (CISP), Italy (as Lead partner); Società Cooperativa Culture (COOPCULTURE), Italy; the Jordan University of Science and Technology (JUST) Jordan; the Association for the Protection of Jabal Moussa (APJM), Lebanon; the Royal Marine Conservation Society of Jordan (JREDS), Jordan; Palestinian Heritage Trail (PHT), Palestine; the Italian Ministry of Culture (MiC), Italy.

**CROSSDEV expects to** increase tourism competitiveness and attractiveness of less known destinations and rural areas, enhancing the Cultural Routes experiences of the Council of Europe in Italy, Jordan, Lebanon, Palestine, specifically:

**Italy:** Sicily, communities of the areas along the **Via Selinuntina**

**Jordan:** communities around the less-known historical and cultural sites in the **Aqaba** area (South of the country) and in the **Umm Qais** archaeological site (North of the country)

**Lebanon:** villages and cultural sites in and around the **Jabal Moussa Biosphere Reserve** area, Mount Lebanon

**Palestine:** communities along the **Palestinian Heritage Trail**.

**CROSSDEV's goal is to** contribute to economic and social development in the Mediterranean by strengthening and enhancing sustainable tourism policies and practices and highlighting common cultural heritage, environmental trails, and resources to be turned into assets for socio-economic local development.

RESPONSIBLE TOURISM in terms of acceptance of others and respectful behaviours, respect and defence of human rights, nature protection, social economic and environmental sustainability.	

## IN FULL SUPPORT OF

The principles expressed in The Convention on the Value of Cultural Heritage for Society (Faro Convention, 2005), The Resolution of the Council of Europe and the Representatives of the Governments of the Member States meeting within the Council on the Cultural Dimension of Sustainable Development (November 2019), The New Agenda of the Mediterranean (February 2021) and the Renewed partnership with the Southern Neighbourhood, the UNESCO Conventions on Protection of Tangible and Intangible Natural and Cultural Heritage (1972, 2001, 2003), the 2030 Agenda for Sustainable Development and the sustainability criteria outlined by the Global Sustainable Tourism Council (GSTC), more specifically the GSTC-D scheme defining sustainability requirements for tourism destinations.

## THE PARTIES AGREE

## In order to achieve this goal, the parties will

- Promote the Hidden Mediterranean platform at the widest possible scale all over the Mediterranean and beyond.
- Implement the promotional campaign designed within the project through destinations' websites, partners' websites and social media channels, through Hidden Mediterranean social media accounts (Facebook and Instagram), through B2Bs, fairs and events.
- Enlarge the platform by including relevant local actors along the tourism value chain (e.g. Destination Management Organisations; Tour Operators and Travel Agencies; Tourism Accommodations; Professionals in

the Cultural Heritage Sector; Food & Beverage Operators; Cultural Tourism Attractions; Natural and Cultural Guides; Eco museums, Local Museums; Transport service providers; Craftsmen and Artists; Producers; Shops; Residents; Responsible Tourists; all other actors that can directly and indirectly benefit from tourism) so as to contribute in an effective way to move towards sustainable tourism in the Mediterranean, in line with the objectives of the Agenda 2030.

- Implement sustainable management practices to foster the contribution of tourism to local development through protecting and managing cultural and natural heritage
- Develop innovative tourism products and initiatives in line with the general objectives of the CROSSDEV project and “Hidden Mediterranean” identity and co-marketing of tourism products
- Ensure the greatest accessibility and inclusiveness of the tourism offer, also by making clever use of technology
- Encourage direct cooperation, exchange processes, and best-practices transfer between CROSSDEV destinations and other destinations in the Mediterranean area that can be ambassadors of common values, for improving the development and management of sustainable tourism as a toll for socioeconomic sustainable development
- Continue to apply the lessons learned to enhance future tourism policies and action plans, as an important legacy of the project
