All parts of the tender other than the financial offer must be submitted in E-mail A (i.e. including the tender submission form and declarations).

In case the tenderers passed the technical evaluation, an email will be sent to the Tenderers who passed the technical evaluation requesting for the password of the financial offer.

2. TECHNICAL INFORMATION

The tenderers are required to provide services as indicated below during the project's life cycle.

- 1- Review the communication and dissemination strategy and the guideline.
- 2- Attend the project's meetings.
- 3- Create web and social media contents addressed to the project target groups to be published in website as well as the project's social media accounts.
- 4- Ensure the coherent implementation of the communication strategy and communication guidelines.
- 5- Monitor the effectiveness of the communications strategy by collecting data and assessing it against the KPIs indicated in the Communication and Dissemination Strategy
- 6- Review the communication reports that will be submitted to the project lead.
- 7- Ensure the organization of the local events following the sustainability criteria.

- Tenderer must have experience managing at least one other staff member.
- Familiarity with waste management, water, energy and/or environment-focused initiatives is a plus.
- Tenderers must have solid knowledge in awareness raising campaigns, events' management, and implementation of the communication activities for diverse audiences. This experience must be highlighted in the submitted CV.
- Knowledge of one or more local languages desired, Fluency of English is required.
- Experience designing and implementing innovative awareness raising activities.
- Familiarity designing communications and outreach activities for public, private, and NGO sector representatives, as well as women and youth.
- Relationships with local press and media representatives highly desired
